FAA Town Hall Meeting per KAEG Bravo Taxiway Closure Proposal, 4pm April 17: Mike Medley, Double Eagle II Airport Manager invites anyone interested to attend. The FAA will be conducting a town hall meeting regarding the Taxiway B “end around” issue on Thursday, April 17, 2014 from 4:00 PM to 6:00 PM at the Airfield Maintenance Facility at DEII. Due to FAA review of instrument approaches, they propose elimination of the northernmost portions of Taxiway Bravo and Alpha at Double Eagle II Airport per attached diagram. The proposed change would involve extension of taxiway A1, crossing runway 4/22 as the primary access to runway 17/35. As we understand it, the problem is if an aircraft higher than 14 ft uses the north end of taxiway Bravo to access runway 17/35 when someone is on the instrument approach when the tower is closed (at night). Tim Baribeau, AEG Tower Manager, held a Runway Safety Meeting last week where the proposed change was discussed. Participants raised the issue of increased runway safety risk due to everyday use of runway 17/35. Any questions, contact Mike at 505-244-7888 or Mobile 505-259-8113.






